The interests of Member Organisations, while aligned to their respective global federations, overlap in their desire to see the promotion of the values which Taekwondo engenders and the growth of the martial art and sport in all its forms across the UK.

Through BTC, Member Organisations will be able, and encouraged, to:

- Identify opportunities to deliver greater value for money through sharing common services where this is commercially advantageous
- Cross-reference databases and share other member information to improve data management and services provided to participants
- Register their instructors and utilise the instructor/coach development programmes available to promote best practice and the safe facilitation of Taekwondo











#### **Job description**
